Pesticide Use Reminders for Landscapers

Moss and weeds in landscaping, driveways, roofs, and gardens can be a widespread problem in the damp areas of the Pacific Northwest. It is not uncommon for people to use products that prevent growth or kill existing moss and weeds (e.g., weed and feed). Many people do not know that these types of products are classified as pesticides under state and federal law and that pesticide licensing is required before applying them commercially. Additionally, each product must be registered before being applied commercially to control moss, weeds, or other pests on a customer's property.

The Oregon Department of Agriculture (ODA) Pesticides Program regulates the sale, use and distribution of pesticides in Oregon. Our goal is to protect people and the environment from adverse effects of pesticide use while maintaining the availability of pesticides for beneficial uses. The main ways that we do this are through pesticide licensing, pesticide product registration, pesticide investigations, and compliance monitoring.

During pesticide investigations, we look to see whether pesticides are being used according to their labels, whether the pesticide applicator(s) are wearing appropriate personal protective equipment, and whether the pesticide applicator(s) and their employer have the appropriate pesticide licensing and have kept the required records.

Individuals and businesses must be licensed by ODA before performing certain pesticide-related activities. In general, a commercial pesticide

applicator license is required to apply a pesticide to a |customer's property. Additionally, their employer (business) must have a commercial pesticide operator license. Commercial pesticide licenses also have license https://oda.direct/SearchRegisteredPesticides categories, which may limit or specify the type of pesticides that can be used and/or locations where pesticides can be applied.

The pesticide label must always be followed. Pesticide product labels provide critical information about how to safely and legally handle and use pesticide products. This includes information, such as mixing (dilution) rates, where and how much to apply, requirements to prevent off-target movement and protect waterways, emergency first aid instructions, and how to dispose of the empty container. Pesticide labels are lawfully enforceable, and carry the statement, "It is a violation of Federal law to use this product in a manner inconsistent with its labeling." In other words, the label is the law.

LCB Proposed 2025-27 Budget and Fee Change

The Landscape Contractors Board is accepting public comments regarding the agency's operating budget and a proposed fee change beginning October 1, 2025.

A Notice of Proposed Rulemaking was published in the Secretary of State's Oregon Bulletin on April 1, 2025. You can view the full notice and related documents on the LCB website <u>www.Oregon.gov/LCB</u> on the Laws and Rules page.

Summary of Amended Administrative Rules

This proposed rule makes three changes related to the LCB budget (OAR 808- 001-0008) and fees (OAR 808-003-0130):

1. Amends the current 2023-2025 operating budget to include unplanned increases in costs and income

Proposed 2023-2025 Modified Budget Document

1. 2. Proposes the 2025-2027 biennial operating budget <u>Proposed 2025-2027 Budget which</u> <u>includes fee increase</u>

3. Proposes a \$30 fee increase to application and licensing fees and a \$10 increase to other fees, beginning October 1, 2025 (Other fees include late fees, status change fees, and reinstatement fees)

Legislative Updates

Here are some bills of interest we are tracking in the 2025 legislative session:

SB 864 A: Changes the LCB bond structure to require \$20,000 bond for all landscape contracting businesses.

SB 865: Amends LCB statutes to: include work under exemptions (tree work, low voltage lighting, backflow) in the definition of work as an independent contractor; clarify that both LCB and CCB licensees can install ornamental water features; and include all consumers in the right to cancel a contract.

HB 2067 A: Establishes a rebate program for the purchase of battery-powered leaf blowers

SB 360: Creates a pesticide licensing exemption for certain employees using a battery-powered device to apply pesticides.
